The Annual General Meeting of South Island Rowing Inc was held in Christchurch on June 30<sup>th</sup>. The venue was one of the better venues and the hosts clearly have arranged a number of these sorts of occasions before. Since I remain as the Secretary, I can continue to try an provide information about our activities and the events that shape rowing at lake Ruataniwha.

The meeting itself covered a wide range of topics and one thing this edition of the newsletter will do is share some of the outcomes. Being a General Meeting there was no restriction on attendance and it was good to see so many from various parts of the South Island making the effort to be involved.

It is an unfortunate consequence of Annual General Meetings that we do not cover all the details due to a lack of time and this was quite evident at this last meeting. In some ways we are at the crossroads in terms of the future development of the Lake Ruataniwha Rowing Facilities and some of the strategic planning activities have been held over until a subsequent meeting.

We do thank the few who have taken the time to provide input into our various activities and who assist in many and varied ways. Many of the improvements have originated from this feedback and this will continue to be a source of development information

## Course

The course has its own unique problems and Trevor advised that he did want the course to be better for the main regattas. However, after seeing the courses used for some of the International Regattas overseas, he concluded that even in its developmental state ours did compare very favourably.

The most recent working bee saw a start made on setting up the new buoys. This involves a revised methodology for the buoy attachment and is expected to result in an easy install and change process for the course.

A sample "orange" buoy was provided for the AGM and it was decided that this will be the colour of the next purchase once numbers have been quantified. The Course Manager has advised that there will be four more working bees this year. He will be advising of the dates with the first proposed for 28<sup>th</sup> & 29<sup>th</sup> July. # Safety

Safety continues to be the main reason for undertaking many of the works. It was petrol handling that featured to some extent at the AGM and it was very interesting to hear of the practices employed by other organizations. While many "get away" with practices that are contrary to the legal requirements it is possible that SIR could do so to and there is an element who are prepared to take this risk.

But, if there is an incident we are liable for prosecution and any insurance becomes void. No one volunteered to take this risk in an area such as Twizel where the conditions are extreme and an incident more likely than other areas. It is for this reason that we resolved to err on the conservative side of safety and progressively implement the safety requirements.

### **Environmental Protection**

**Didymo** (aptly called rock snot) is a major problem in the area. We know that it is prevalent in much of the Waitaki and some of the feeder streams. So, the risk is very real and we expect all users to act responsibly by cleaning and drying their equipment before and after using the lake.

We understand there has been a development in the type of detergent that we must use to wash the boats. While this is reported as being more effective and environmentally friendly it is more expensive and inevitably costs more. Please note that the practice of washing boats before and after use will remain in place for the coming season.

Wilding Pines continue to be a problem in the area and the SIR land is no different. This particular pest grows quite prolifically and often to the detriment of the environment. We need to keep a close watch on this pest and remove the seedlings while they are young and before they have opportunity to seed.

This is just another of the working bee activities that need to be addressed.

# Fencing

Mike McClelland advised the AGM that the fencing is progressing well. The completion of this project will add a level of security to the boat park in particular. It also allows us to denote the boundary of the SIR property, provide signage advising of the potential hazards and minimise the likelihood of injury accidents.

Given the information previously distributed information on the need for the fence, it was interesting to hear questions at the AGM about the need for this fence. Strangely, no one seemed to be prepared to face the prosecution that could arise from having no warning and protection from hazardous plant items. Health and safety remain one of our main concerns
